



# Baku Energy Storage Industry Policy

1 &#0183; The 2024 meeting of the UN Climate Change Conference--known as COP29--will be held in Baku on November 11-22. Azerbaijan"s hosting of the summit has come under ...

The organisers of the COP29 climate summit -- due to take place in oil-producing Azerbaijan 11-22 November -- have proposed a six-fold increase in global energy storage capacity and the creation of a fair transition fund financed by fossil fuel producers among their ambitions for the event, but have made no mention of any plan to phase out fossil fuels.

The Baku Energy Week, a significant event in the region"s energy sector, will be held on June 4-6. It encompasses three prestigious events: the 29th International Caspian Oil and Gas Exhibition - Caspian Oil& Gas, the 12th Caspian International Energy and Green Energy Exhibition - Caspian Power, and the 29th Baku Energy Forum.
