The regulation of the European Parliament and the Council will apply to all batteries including all waste portable batteries, electric vehicle batteries, industrial batteries, starting, lighting and ignition (SLI) batteries (used mostly for vehicles and machinery) and batteries for light means of transport (e.g. electric bikes, e-mopeds, e-scooters).

The manufacturer must draw up an EU declaration of conformity for each battery model. The manufacturer must draw up certain technical documentation. The manufacturer shall operate an approved quality system for the production, inspection and testing of the finished product and shall be subject to surveillance.

An export declaration is an official document in which you specify details about the goods you export. If you are a company based in the UK and export goods on a permanent basis to customers outside the UK, you must complete and submit an electronic export declaration via the National Export System (NES).
