Packaging: Each battery /cell must be protected against a short circuit and placed in an inner packaging that completely encloses the battery /cell, then placed in a strong rigid outer packaging. State of Charge (SoC) of the battery or cell must not exceed 30%.

Protect terminals by completely covering them with an insulating, non-conductive material (e.g., using electrical tape or enclosing each battery separately in a plastic bag), or packing each battery in fully enclosed inner packaging to

For shipping a lithium ion battery in equipment, does the maximum cell power restriction also apply? 1) Mfrs were required to print the battery capacity on the label beginning in 2011. 2) Limitation for battery capacity is 100 Wh (to avoid Dangerous Goods Declaration). 3) Limitation for cell capacity is 20 Wh (to avoid Dangerous Goods Declaration).
