You're allowed to bring 15 electronic devices with a lithium battery up to 100 Wh with you in your checked baggage. These devices need to be completely switched off. If you want to bring a device with a lithium battery up to 160 Wh, you need to request permission. Devices with batteries larger than 160 Wh are never allowed.

Passengers can carry most consumer-type batteries and portable battery-powered electronic devices for their own personal use in carry-on baggage.

However, you must pay special attention to the restrictions on liquids, batteries and some other items. Quick check: what items are allowed. The table below gives you a general overview of what you can or cannot bring on board. Note that most of these items have restrictions on them, please read further details after the table.

Examples of non-spillable wet batteries: gel batteries or AGM batteries. Examples of dry batteries: nickel metal hydride batteries, nickel cadmium, alkaline manganese or zinc carbon batteries. Conditions of carriage for non-spillable wet and dry batteries: Non-spillable wet batteries (e.g. gel batteries) must not contain free or unabsorbed liquid.
