India currently imposes a 15% safeguard import duty on solar panels and modules imported from China and Malaysia. This safeguard duty was imposed in July 2018 to protect the domestic solar manufacturing industry from a surge in imports.

However, clarification is needed on the continuation of the safeguard duty (SGD) on imported cells and modules, which is currently at 14.5 per cent, valid till July 2021.

The Indian Solar Manufacturers Association (ISMA) has filed a petition with the Directorate General of Safeguards that seeks to impose a Safeguard Duty on imported solar cells from China, Malaysia, Singapore and Taiwan. ISMA has already filed an anti-dumping petition in June with the Ministry of Trade and Commerce, against Chinese solar modules and cells.
