



Do I need a license to sell battery packs

UN/DOT. In order to ship ANY lithium battery products via air freight, the UN 38.3 test must be passed by the battery packs. New regulations were passed in 2016 that tighten requirements for shipments of lithium products and that forbid lithium batteries to be shipped on passenger aircraft.

My best recommendation hands down, order a watch repair kit off Amazon, and packs of batteries. Probably 80% of batteries for watches are the same kind, and they're dirt cheap on Amazon. That is, if you plan on selling multiple watches. If you only have 1 to sell, well, it's up to you if it's worth your while.

Therefore, these packages do not need shipping papers, such as a Hazmat Certification [OP-950] or OP-900 Hazmat tags. These packages will not need to be packaged in UN POP (performance oriented packaging), nor are they subject to the hazmat surcharge. The packages must display a battery handling mark to qualify for this exception.

The disassembly of a battery pack into individual modules or cells with no damage done to the cell casing does not make a battery damaged or defective. Damaged, defective, or recalled batteries may not be
