President Biden signed the Inflation Reduction Act into law on Tuesday, August 16, 2022. One of the many things this act accomplishes is the expansion of the Federal Tax Credit for Solar Photovoltaics, also known as the Investment Tax Credit (ITC). This credit can be claimed on federal income taxes for a percentage of the cost of a solar photovoltaic (PV) system.

Its opposition to solar isn"t unusual. Some homeowners" associations are concerned that solar panels will reduce property value, even though the opposite is true: rooftop solar actually increases home values by an average of \$15,000. In fact, North Carolina even exempts the increase in property value due to rooftop solar from property taxes.
