Important tip. The number of hours that photovoltaic panels produce solar energy every year is not equal to the number of hours of daylight. The solar energy generated by photovoltaic panels depends on their orientation, their inclination, the height of the sun and the cloud cover, so it's imperative not to overestimate the hours your installation will produce energy.

Florida law forbids ordinances, deed restrictions, covenants, or similar binding agreements from prohibiting solar equipment use. Under this law, a homeowner may not be denied by "any entity granted the power or
