Share Price Determination. The share price for restricted stock grants is typically based on the market value of the company's stock at the time of the grant. Some companies may also use an average stock price over a specified period to determine the value of the restricted shares.

The vesting period is three years of your continued employment at the company. At vesting the stock price is \$15. You now own company stock valued at \$15,000. With restricted stock units, no stock is actually issued to you at the time when your company awards you the grant of RSUs. The shares are not outstanding until they are released to you.
