A "Power Purchase Agreement" (PPA) is a contractual agreement usually entered between private sector companies and public sector companies for purchase of power. PPA is the initial agreement that enables "Public-Private Partnership" (PPP) within power sector. Most often, it is a state-owned purchaser (also referred as "off-taker") contracting with private ...
