On February 4, 2022, the White House announced that President Biden extended for another four years the Section 201 tariffs on imported crystalline silicon solar panels. The president raised the annual tariff rate quota for solar cells from 2.5 gigawatts to 5 gigawatts. The U.S. imported approximately 2.7 gigawatts of solar cells last year.

The US imported 55 gigawatts of panels and 3.8GW of solar cells in 2023, with more than three-quarters of cell imports coming from Malaysia, South Korea and Vietnam, according to BloombergNEF.

According to the White House announcement released on Monday evening, the tariff quota for solar cells will increase from 5GW to 12.5GW, and the tariff is currently set at 14.25%. In May of this year, the Biden administration said that if the import volume of photovoltaic cells approaches the 5GW level, it will consider raising the quota.
