Renewable Fuel Producer Excise Tax and Inspection Exemption. The first 1,000 gallons of renewable fuel that an individual produces each year are exempt from the motor vehicle fuel excise tax, the petroleum inspection fee, and any petroleum inspection requirements not required under federal law.

8101.3 Permit and inspection fees. Permit and inspection fees are based on the average time to complete the type of work specified.
